ALL RESIDENTS ARE REMINDED THAT METRO VANCOUVER HAD INTRODUCED NEW REGULATIONS WITH RESPECT TO CHANGES FOR RECYCLING AND GARBAGE PICK-UP. THESE REGULATIONS TOOK PLACE JANUARY 1, 2008 AND PLACED STRICT RESTRICTIONS ON WHAT IS ALLOWABLE FOR DISPOSAL IN EITHER GARBAGE OR THE RECYCLING BINS.

VARIOUS ITEMS (INCLUSIVE OF BUT NOT LIMITED TO, SOFAS, TELEVISIONS, COMPUTERS, CLOTHING, USED AUTO PARTS, ETC.) ARE NOT PERMITTED TO BE DISCARDED IN EITHER THE GARBAGE/WASTE BIN OR THE RECYCLING CONTAINERS PROVIDED FOR USE BY RESIDENTS RESIDING WITHIN THE STRATA CORPORATION.

PLEASE NOTE THAT VARIOUS CHARITIES AND OTHER ORGANIZATIONS OFFER SERVICE AND, IN SOME CASES, WILL COLLECT THESE ITEMS FROM YOU AT NO CHARGE, THEREBY ALLEVIATING PROBLEMS ENCOUNTERED WITH DISPOSAL.
